RBanerjee, a Memorial Award bearing his name has been initiated. A child of one of the stakeholders of the institution is awarded a memento in recognition of a commendable achievement. However during the pandemics the function couldn't be arranged for two consecutive years

on the stipulated date of 1^{st} July, due to covid related restriction protocols.

Evidence of success: The final semester results are a decent indicator of the success of this function. There has been an increment of average CGPA of final semester students of various over disciplines the previous years. Moreover, students have also excelled in co-curricular activities. The Practice: Keeping in mind the urge for practicing green initiatives in the institution several programs and projects were undertaken.

- A rainwater harvesting plant was set up within the campus to recharge the ground water level. There has been rapid depletion in the ground water level in the town due to several reasons and the construction of the harvesting plant would retard the effect however small.
- The Eco-Club of the institution has commenced several initiatives to replenish the greenery of the campus and other adjoining areas. Several plantation programs inside and the surrounding areas of the campus as well as in the adopted villages of the institutions were undertaken.
- Several measures were initiated to beautify the campus. A waste dump in front of the Ladies Hostel was converted to a park increasing the aesthetic value of the surroundings.
- A medicinal plant garden is also maintained by the Eco Club.
- The Office has shifted largely towards paperless administration. Several major activities like Admission and Examination related processes are now entirely online. The salary of the stake holders and

- World Environment Day every year is observed. Plantation programs and awareness campaigns amongst the students and also in the localities are organized round the year.
