- 1) The college is to have in due course an enrolment upto 600 students with Degree Courses (Arts & Science) and also University Entrance Course (Arts & Science);

For the present, the college will obtain affiliation of the University concerned on the following subjects in University Entrance Course in Arts and First year of the Three Years' Degree Course in Arts :-

English, Bengali, Sanskrit, History, Logic and Philosophy, Economics and Political Science, Mathematics.

- 2) The rates of fees for students should be fixed at the rates already prescribed and charged in other sponsored colleges;
- 3) The college should at present appoint and maintain the staff as detailed in the annexed statement, according to the actual requirements and in conformity with the University Regulations and with requisite qualifications and scales of pay already approved by Government;
- 4) The college should have a properly constituted Governing Body;
- 5) The actual annual deficit towards the maintenance of the college will be met by the State Government;
- 6) The college will be run in accordance with the terms and conditions of a sponsored college as approved in terms of G.O. No.11173-Edn. dated 31.10.56;

The recurring expenditure towards the maintenance of the college is estimated as follows :-

Immediate	...	Rs. 37,000/- p.a.
Ultimate	...	Rs.1,15,000/- p.a.

Necessary grant towards the purchase of furniture, equipment and books will be sanctioned in due course.

Pending construction of college building, the authorities of the college will provide rent-free accommodation for running the college from the current academic session.



With reference to your application dated 7.9.62 & 17.12.62, I am directed to state that your college has been granted extension of affiliation in the following subjects and courses of study:-

a) B.Com. upto Pass standard in the evening with usual compulsory subjects and adv. accountancy and auditing as elective group.

b) U.E. course with English, Bengali, Hindi, Com. Geography, Com. Arithmetic and Book-keeping and with Logic, History and Sanskrit as a special case in the evening provided that the students to be admitted in the evening U.E. Class must have whole-time employment in the day-time

The affiliation will take effect from the session 1963-64 with permission to present candidates for the B.Com. Part-I Examination in 1965 and the U.E. Examination in 1964 and not earlier. This is subject to the provisions of the University Ordinances relating to conferment of Degrees, Titles etc. and subject to provision being made by the college of such requirement in respect of accommodation, equipment, teaching staff etc. as may be laid down by the University.

The following conditions are to be fulfilled:-

It was stipulated in Government Order No.1080-Edn(CS) dated the 28th October, 1970 by which the integrated scale of pay was introduced, that financial assistance  $\chi$  on the terms contained in that Government Order and subsequent Government Orders on the subject, would be admissible to the colleges only in respect of posts which had already been approved by the Government. Pending the fixation of the norm of work-load for college teachers, the Governor was pleased to declare in G.O.No.1080-Edn(CS) dated the 28th October, 1970 that posts created in affiliated including sponsored colleges on or after the 1st April, 1966 and existing on the 1st September, 1970, should be treated as approved without scrutiny for facilitating the release of financial assistance to the colleges concerned.


